Information ex art. 13 EU Regulation 2016/679 GDPR - Processing of personal data for the submission of applications for financial contribution

Holder of the data

Pursuant to EU Regulation 2016/679 GDPR ("Regulation"), personal data collected for the purpose of submitting applications for financial commitment for the Meet in Italy for Life Sciences 2021 event will be processed by Liguria Digitale S.p.A. with headquarters in Via Melen 77 - 16152 Genova as Data Controller.

Type of data being processed

The Data Controller will process your personal data including identification and accounting data.

Purpose and lawfulness of the processing:

Personal data will be processed for the following purposes:

- A) Receipt of requests for financial contribution;
- B) Examination and verification of meeting requirements;
- C) Administrative activities deriving from the acceptance of the application;

For the processing of the personal data indicated above, the legal scope is the following:

- execution of a contract of which the interested party is a party or the adoption of pre-contractual measures adopted at the request of the same (Article 6 letter b) of the GDPR).

The provision of your personal data for the aforementioned purpose is optional but failing to do so it will not be possible to proceed with the aforementioned goal.

With reference to the aforementioned goal, the processing of personal data takes place using manual and IT tools with a logic strictly related to the goal itself and, in any case, with methods such as to guarantee the security and confidentiality of the data, in addition to compliance with the specific obligations laid down by law.

Recipients of personal data

Personal data may be shared with:

1. Physical persons authorized by the Data Controller to process personal data (e.g. employees);
2. The organising committee Meet in Italy for Life Sciences 2021
3. Subjects, entities or authorities to whom it is mandatory to communicate your personal data pursuant to legal provisions or orders from the authorities.

Retention of personal data

The data retention period is equal to that necessary for the purposes for which they are collected, respecting the minimization principle referred to in art. 5, par. 1, lett. c) of the GDPR.

Exercise of the rights of the interested party (pursuant to articles 15 and subsequent Regulations)

The interested party has the right to ask the Data Controller, at any time, to access personal data, correct or delete them or to oppose their treatment, limitation of treatment in the cases as provided under art. 18 of the Regulation, as well as obtaining copies of the data concerning themselves in a structured format, commonly used and readable by an automatic device, in the cases provided for by art. 20 of the Regulation.

Requests to exercise such rights must be sent in writing to the Data Controller at the following addresses:
